## Students, FIRE put heat on WVU free speech rules Civil rights foundation joins campus protest

WVU students have fueled the fire in their attempt to extinguish the university's free speech zone policy.

The Foundation for Individual Rights in Education, commonly known as FIRE, has joined outspoken students to drop WVU's policy that limits free speech and assembly to two classroom-sized areas at the downtown campus.

FIRE blasted WVU in a press release Thursday and called the policy a violation of the university's moral and constitutional obligations.

On Feb. 11, FIRE wrote a letter to President David C. Hardesty Jr. urging him "to tear down the barriers to speech and declare all of WVU a 'free speech zone.'"

Beverly D. Kerr, associate general counsel of WVU, responded to FIRE in a letter stating that she would share FIRE's letter with the Faculty Senate Committee in charge of reviewing the policy.

FIRE is a Philadelphia-based, nonprofit organization devoted to civil liberty rights on the nation's college campuses.

## Campus protests continue

The Foundation for Individual Rights in Education, Inc.

About a dozen students representing Students for Economic Justice, Young Democrats, College Republicans and the W.Va. Animal Rights Coalition led protests Thursday against WVU's free speech policy.

Students held signs and handed out hundreds of fliers at the Beechurst and Engineering PRT stations.

"The purpose was to get people involved and let them know that a Faculty Senate committee will be making a recommendation in early April," said Nathan Moore, an SEJ member. "More free speech zones are really not enough."

Moore said the SEJ will hold a press conference at noon April 1 in the Blackwater Room at the Mountainlair.

There the SEJ will present its own free speech policy and recommend it to WVU's administration.
