

**Resolution 16.37:** Resolution on the creation of a Media Publications Fund

Recognizing that there are inherent complications with a student government directly funding campus media publications

Appreciating the very important role of student journalism on a college campus

Acknowledging that the WSA has never attempted to defund *The Argus* 

<u>Understanding</u> that publications such as *The Ankh, Hermes, Method Magazine, Arcadia, Unlocked Magazine, The Hangman's Lime*, among many others, also require funds to operate and improve distribution

Noting that at several of our peer institutions, student journalism is not funded by student governments

Working towards a lasting solution to ameliorate the conflicts faced in the 2015-2016 school year

Believing that as a campus we can come together in unity to support all student groups, including *The Argus* and the WSA

Therefore, be it resolved that the Wesleyan Student Assembly:

- 1. <u>Establishes</u> a stand-alone "Media Publications Fund" for the sole purpose of funding student publications
- 2. <u>Suggests</u> that \$60,000<sup>1</sup> be siphoned from the Student Activities funds at the beginning of the 2016-2017 school year to endow the Media Publications Fund for one year
- 3. <u>Proposes</u> that beginning with the 2017-2018 school year, the Media Publications Fund is supported by a \$13 per-semester "student voluntary opt-out fee" modeled after the Green Fund<sup>2</sup>

<sup>&</sup>lt;sup>1</sup> This number was carefully deduced after taking into consideration how much funding student media publications have received from the SBC in past school years, and by anticipating growth rates of operating costs, establishment of new student media publications, and inflation.

<sup>&</sup>lt;sup>2</sup> The Green Fund received a yield of 87% of the Student Body who chose not to opt-out of the voluntary fee in the 2015-2016 school year.

- a. \* This proposal is subject to referendum in the Spring of 2016, and subsequently Board of Trustee approval during the 2016-2017 school year. If this proposal fails to receive support in <u>both</u> aforementioned regards, it is resolved that the Media Publications Fund be endowed in perpetuity by an annual sum of <u>no less</u> than \$60,000 siphoned out of the Student Activities funds at the beginning of each school year.
- b. If less than \$30,000 is raised from the opt-out fee in a given semester, the SBC will make up the difference from its budget.
- 4. <u>Notes</u> that the Media Publications Fund will be separate from the Student Activities funds, and thus not under the purview of the WSA
- 5. <u>Establishes</u> that the "Media Publications Fund Committee" will be created, and given sole responsibility for all Media Publications Fund budget decisions
- 6. <u>Advocates</u> for said committee to be comprised of one representative from each established publication<sup>3</sup>, two WSA elected representatives, and the SBC vice-chair
- 7. Expects that the Media Publications Fund Committee will establish its own official bylaws
- 8. <u>Proposes</u> that *any* student group has the right to apply for funding from the Media Publications Fund Committee, with the Committee possessing sole discretion over whether or not to grant funding, and if so, how much
- 9. <u>Notes</u> that the *Digitization and Stipends Working Group* will advise the Media Publications Fund Committee
- 10. <u>Recommends</u> a reexamination of the Student Activities Fee in following years upon the implementation of this Resolution

The WSA resolves to remain actively seized in the matter.

<sup>&</sup>lt;sup>3</sup> To be considered an *established publication*, a student group must publish at least two issues in a school year, and have been publishing for the prior 3 consecutive school years
