

Attachment 7a.(3) – Describe Harassment

Tulia

On November 26, 2019, Diane Klein was at a meeting on the university campus. On exiting the meeting, Diane Klein was overheard speaking about me, by two witnesses, telling Charles Doskow that, "...if we are to survive, we have to be willing to assassinate Jendayi, and I for one am willing to assassinate her". This threat was reported to the proper authorities in the University and a formal investigation conducted by an outside firm commenced. Several witnesses were interviewed including Professors Klein and Doskow. The investigator reported that Professor Klein admitted to the "assassination" remark and claimed that it was covered under academic freedom. Professor Doskow acknowledged the sentiment (although not the word assassinate) in stating that "we don't mind anything bad happening to Jendayi. We would do what we could to impede her professionally and hope that she doesn't become the Dean."

The investigator's report found that Diane Klein violated the university's Faculty Handbook and Employee Handbook policies against threatening and harassing conduct.

On January 9, 2020, Diane Klein's tenure appointment and employment at the University of La Verne was terminated. I believe the loss of her employment makes her even more likely to attempt to carry out this threat.
