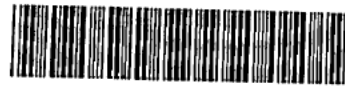

On 12/12/2019, [REDACTED] came to the University of Maryland Police station to report inappropriate electronic messages she was receiving through the application "GroupMe." [REDACTED] is a University of Maryland student and resides within the statutory jurisdiction of the University of Maryland Police. At the time she was a member of a group chat within GroupMe relating to one of her college courses. She reported to PFC N. Nagy #449 of the University of Maryland Police that on 12/10/2019 she received a private message from a person calling themselves "Aang Hoang Ho." This person began the conversation by asking [REDACTED] if she was Jewish and then sent her several messages that harassed her because of her Jewish faith.

On 12/12/2019 "Aang Hoang Ho" contacted her again in the same fashion, again disparaging her for her Jewish faith. On 12/17/2019 he contacted her again, but was given a clear warning from [REDACTED] to stop communicating with her. She wrote to him "Please stop texting me." He persisted and sent her three additional messages through the app that evening. He then sent her messages on 12/20/2019, 1/8/2020, and 1/11/2020 where he told her that he was going to find her home address, name, and face and post it to an online list.

Through investigation, I, D/Cpl. A. Ross #375 of the University of Maryland Police - Criminal Investigations Unit, identified a person of interest, Muqarrab Ahmed Abdullah who was in the same class as [REDACTED] and had created the GroupMe chat. On 2/20/2020, Abdullah agreed to speak with me about this incident. He admitted to using the pseudonym "Aang Hoang Ho" in order to anonymously target approximately five Jewish students within his classes, including [REDACTED]. He did so because of perceived injustices relating to the Israel/Palestine conflict. During the interview, he agreed to write a letter of apology to [REDACTED] and also completed a written statement detailing how he was able to create the fictitious persona and why he chose particular students based upon their Jewish faith.

All events occurred in Prince George's County, Maryland.
