This matter is before the Court on Petitioner's Motion for Traditional Summary Judgment, filed August 12, 2022. Upon consideration of the Motion, its supporting evidence, Respondent's opposition, and the parties' arguments, the Court has determined that Petitioner is entitled to judgment as a matter of law on its Original Petition seeking a Writ of Mandamus to compel Respondent to disclose public information under the Texas Public Information Act. Therefore, it is hereby **ORDERED** that Petitioner's Motion for Summary Judgment is **GRANTED**.

As a result, the Court **GRANTS** the Petition for a Writ of Mandamus and **DIRECTS** Respondent to disclose all records responsive to Petitioner's October 5, 2021 and December 3, 2021 records requests no later than 21 days after the date this order is filed. To the extent responsive records contain students' or parents' personally identifiable information, Respondent must redact such information and produce the records.

The Court also **ORDERS** under Texas Government Code Section 552.323 that Respondent pay Petitioner its costs of litigation and reasonable attorney's fees. The Court will determine the amount after an evidentiary hearing. Petitioner shall submit current proof of litigation costs and reasonable attorney's fees within seven days of this order.
