



Community Living Standards

Department of Residential Life

Updated as of 5/1/2023

As a resident of North Carolina Central University, you assume an obligation to conduct yourself in a manner aligned with the institution's philosophy. The purpose of the Community Living Standards is to outline the rights and responsibilities designed to create a positive living and learning environment within the residence halls. You are responsible for complying with the all rules and policies that are outlined in this document, in the housing agreement, as well as any policies sent to your student account or email.

Please note that provisions may be added, revised, changed during the term of the Housing Agreement. Jurisdiction of residential life community standards will be upheld by Residential Life staff and the office of Student Conduct and Community Standards.

Rights and Responsibilities

The department of Residential Life recognizes that students living in residential communities have certain rights that are not to be infringed upon by fellow community members at any time. These rights include:

- The right to sleep during the night.
- The right to study in rooms, apartments, and common areas without being disturbed during hours designated as "quiet hours"
- The right to be informed of community events or planned disruptions.
- The right to have well-maintained facilities.
- The right to access one's living space during all times their building is open.
- The right to privacy.
- The right to readdress grievances.

The department of Residential Life recognizes that students living in residential communities have certain responsibilities to other community members and to their environment. These responsibilities include:

- Avoiding actions which inhibit another community member's ability to sleep and study during quiet hours
- Maintaining one's self in a manner that is not disruptive to the community.
- Working with roommates and neighbors to settle disputes and disagreements in a timely and efficient manner. This may include working together on roommate agreements or neighbor agreements
- Seeking help for themselves and/or others when necessary.
- Addressing University staff in a timely, respectful, and appropriate manner, including both verbal and written responses.



Individual Standards

A. Alcohol

1. Persons 21 years of age may consume alcoholic beverages in their residence room, suite or apartment or in another room, suite or apartment with an assigned occupant who is present and also 21 years of age.
2. Alcohol containers, empty or otherwise, are not permitted in rooms where occupants are under 21, and should not be used as a form of decoration.
3. Persons are prohibited from possessing open containers or consuming alcoholic beverages outside the designated residential areas or in common spaces within residential areas. Common source containers are prohibited.
4. No person of any age may manufacture and/or sell alcoholic beverages in the residence halls or adjoining property.

*(For specific information on North Carolina Central University's policies regarding alcohol, please see the Student Code of Conduct.)

B. Business Enterprises

1. Personal business enterprises shall not be conducted in or from the University residential facilities, including Internet related business operations.

C. Drugs/Drug Paraphernalia

1. The transport, possession, possession with intent to deliver, delivery, manufacture, purchase, sale, distribution, or use of illegal drugs or controlled substances is prohibited.
2. Prescription drugs may only be taken by patients for the intended use and in the prescribed manner as directed by their physician.
3. Possession of drug-related paraphernalia is prohibited.

*(For specific information on North Carolina Central University's policies regarding illegal drugs, please refer to the Policy on Illegal Drugs and the Student Code of Conduct.)

D. Gambling

1. Gambling is not permitted in the residence halls.

*(Unless approved by the Area Coordinator, the sponsoring of raffles or selling tickets is not permitted.)

E. Harassment

1. Harassment, defined as any physical force, violence, threat, intimidation, stalking, or other behavior that interferes with an individual's personal safety, academic efforts,



employment, or participation in University-sponsored activities, is strictly prohibited. This includes, but is not limited to harassment in person, harassment by an accomplice, and harassment by the use of technology.

2. No North Carolina Central University employee or student may engage in conduct that constitutes sexual harassment.

(Sexual harassment is defined in North Carolina Central University's Sexual Misconduct Policy as follows: Unwelcome sexual advances, requests for sexual favors and other verbal or physical conduct or communication of a sexual nature when:

- (i) submission to or rejection of such conduct or communication is a term or condition of education/employment benefits, academic/job related evaluations or opportunities;
- (ii) submission to such conduct or communication substantially interferes with a student's education and/or an employee's job; or
- (iii) such conduct is sufficiently severe, pervasive, and objectively offensive as to have the effect of creating an intimidating or hostile educational/work environment or negatively affects a student's/employee's educational/employment opportunities.

Sexual harassment does not include personal compliments normally welcomed by persons of that sex, or social interaction or relationships freely entered into by university employees and students or student applicants.)

F. Illegal Entry/Trespassing

1. Unauthorized entry into any Residential Life property, including restricted access areas of residence halls, is strictly prohibited. These areas include, but are not limited to, any place that is officially closed, restricted only to designated persons (including other residents' rooms), or where the safety and welfare of residents could be endangered. Examples of restricted areas include mechanical rooms, telecom rooms, roofs, closed buildings, housekeeping closets and storage areas.

G. Physical Violence

1. Physical violence or conduct that threatens the health and safety of one's self or any other person in or around the residence hall community is prohibited.

H. Sexual Assault/Sexual Misconduct

1. Sexual assault and sexual misconduct are prohibited.

*(Sexual assault and sexual misconduct in their various forms are defined under the North Carolina Central University's Sexual Misconduct Policy.)

I. Smoking

1. Smoking is prohibited in residence halls and on all residential hall property within 25 feet of the facility.



*(Items include use of tobacco, and all use of e-cigarettes, personal vaporizers (PV), and/or electronic nicotine delivery systems (ENDS))

J. Theft and Possession of Stolen Goods

1. Theft of any kind or the possession of stolen property is prohibited.
2. Theft or unauthorized Page | 6 Revised June 24, 2020 possession of university owned furniture or property is prohibited.

K. Weapons/Explosives

1. Possession, storage, manufacture, use, sale or distribution of firearms, fireworks, explosive material, ammunition, BB and pellet guns, paint guns, knives, martial arts weapons, and all other dangerous weapons are prohibited.
2. Any item that intentionally resembles an actual weapon is not allowed.
3. For reasons of safety, explosives are not permitted in the residence halls.

Community Standards

A. Damage/Vandalism

1. Vandalism will not be tolerated at the University. Residents will be held responsible for any damages to their rooms or apartments. Common area damages (hallways, lounges, bathrooms, etc.) will be the responsibility of those residing on that residence hall floor or in the apartment unless individuals responsible for the damage are identified.
2. Damage caused through carelessness will result in billing to cover the cost of damages. This can take the form of fines and/or disciplinary action up to the loss of housing. Please remember that drunkenness will not be considered an excuse for vandalism or any other policy violation. This policy can be applied to either groups or individuals.
 - i. Those identified as responsible for careless and malicious acts of vandalism or violation of University regulations may be:
 - ii. Billed for damages.
 - iii. Faced with University judicial action.
 - iv. Released from University housing.
 - v. Individuals wishing to appeal damage charges should contact the Director of Housing and Residence Life in writing with their concerns.

B. Holiday and Break Periods

1. During times when residence halls are closed for break periods, entry or attempted entry by residents is prohibited.
2. Residents are responsible for knowing and complying with break period guidelines set forth by their community.

C. Pets/Aquariums



1. Pets other than fish are prohibited in the residence halls. Residents are permitted to keep fish in their room providing: (a) the fish tank is freshwater and its size does not exceed 12 U.S. gallons; (b) all residents of the room agree to have a fish tank in the room; and (c) all appropriate precautions are taken to ensure that the electrical connection to the fish tank is safe.

*Students found with unauthorized animals will be fined a fee of \$250.00 for each violation, documented through the student conduct process, and will be at risk of having their housing terminated. It is important to remember, residents are responsible for the actions of their guest(s).)

** (This policy does not apply to persons with a disability that require the use of a service animal or emotional support animals. If you require the use of a service animal or emotional support animal, approval from the Office of Student Accessibility Services must be submitted to the Department of Residential Life prior to bringing the animal in the residence halls. Failure to receive prior approval for Emotional Support Animals may revoke privileges of bringing the animals to the residence halls.)

D. ESA and Service Animals

1. Student must obtain written approval from Student Accessibility Services prior to bringing their animal on the campus of North Carolina Central University. Student should begin the approval process by submitting a request through [Eagle Accommodate](#). Any animal that is not approved via SAS are considered unauthorized.

E. Posting Policy

1. No one, with the exception of community staff or a member of hall council may post or distribute materials on campus, including in any residential community, without authorization/approval from the Department of Residential Life. Authorization/approval requires a stamp (provided by Student Engagement and Leadership) on each item to be distributed. The requestor must provide a hard copy of the posting as well as individual contact and organization information with each request.
2. Materials deemed harassing, harmful to the community, or promoting at risk behavior or conduct that violates any University policies, regulations, rules and/or federal or state will not be approved for posting.

F. Quiet Hours/Noise

1. Quiet Study Hours occur daily between 10:00pm and 10:00am. During this time, noise must be kept at levels that will not interfere with the study or sleep of other residents.
2. Quiet Hours are extended to 24 hours during final exams. Excessive noise is defined as any unreasonable noise level that can be heard inside and/or outside of the residence hall room or space from which it originates and is not allowed at any time.



3. Courtesy quiet hours are in effect 24 hours a day, 7 days a week.
4. Placement of sound equipment in windows is prohibited.

G. Recreational Activities

1. Any activity that includes throwing an object or running in the halls is not allowed. Riding a bike, skateboarding, floor hockey, or rollerblading and engaging in sports, including, but not limited to, water fights, Frisbee throwing, horseplay, ball bouncing, golf clubs, basketball playing, etc. are prohibited inside all residence halls

H. Residential Computing Policy

1. Residents of campus housing who register for Ethernet or wireless connectivity agree to abide by the Information Technology Services (ITS) Responsible Use Regulation.
2. Misuse or tampering with an Ethernet or wireless connection is prohibited.

I. Solicitation

1. Recognized student groups must have received prior written approval from the Director of Residential Life.
2. Campaigning for campus student leadership positions must meet regulations set forth by the Elections Board of Student Government and must seek approval from the Director of Residential Life.

J. Visitation Policy

1. Visitation shall be operated on an honor basis in each participating hall.
2. The Visitation policy is a shared responsibility between residents of a community and residential staff. Students are encouraged to notify their Resident Assistant, Graduate Hall Coordinator, or Area Coordinator of potential violations of this policy immediately.
3. Student who do not reside in a specific hall must sign in and out at the main desk of the residence hall. Residential Life at North Carolina Central University defines a visitor as anyone who is NOT assigned to the room, suite, and or building. Each participating resident must sign guests in and out of the residence hall. Current (valid) picture identification is required. The registration must include the name of the guest(s), name of the host and room being visited. Each guest shall enter and leave by the front door of the residence hall being visited. Residents are permitted a maximum of 2 visitors per room/suite. Regardless of room type, there can only be 2 visitors in corridor, suite-style, or apartment-style spaces.
4. Visitors are limited to **NCCU students only**. Non-NCCU Students are prohibited in the residence halls.
5. Visitation from parents/guardians is permitted under certain circumstances. A request must be submitted to your Area Coordinator three business days in advance.
6. Students are responsible for their visitors as long as they are in the room, suites, or building. Students are expected to accompany their guests from the time they enter the building until they exit the building. The host is responsible for the actions of the guest(s) except in situations determined to be beyond their control.



7. The presence of the guest(s) should not result in the unreasonable inconvenience or annoyance to roommates or other residents.
8. Minors (under the age of 18) who have a photo ID must complete a visitor's card upon their arrival. Those under the age of 18 or who do not have a photo ID must file a visitor's card at least 72 hours before their visit. Emergency information will be gathered on this card. The University must have on file the signature of a parent or guardian in order for the minor to visit the facility. Exceptions may be made at the discretion of the Residence Graduate Hall Director and/or Area Coordinator. Visitors are only permitted in the building between the hours of 8:00AM-11:59PM. Guests not are permitted between the hours of 12:00AM-8:00AM.
9. Overnight guests are prohibited including parents/guardians/family members
10. There are periods during the year that a no visitation policy is in place. During this time visitors are not permitted in the building or within student rooms or suites. Below are the periods during the year when there is no visitation
 - Homecoming
 - Fall Commencement
 - Spring Move-In
 - Spring Fling
 - Spring Commencement
11. Visitation is prohibited in rooms, suites, and apartments during exam week. Students may have visitors in common areas such as study rooms, classrooms, lobby areas, etc. for activities supporting academic excellence (studying, tutoring, group projects, etc.).
12. Habitation of a room by anyone other than an individual assigned to that room is prohibited.
13. The visitation policy may be reconsidered by hall staff if there is epidemic of visitation policy violations.

*(Students should remember that a room/ suite is a shared space and everyone in the living space has equal rights. Students are encouraged to talk with their roommates and suitemates about their expectations when visitors are present between the approved hours above. Residents should make sure these expectations are documented in a roommate agreement with their hall staff)

Residential Hall Facilities Standards

A. Decorations

1. When decorating exterior room doors or common areas, the Department of Residential Life requires that residents avoid posting materials that would constitute harassment or



discrimination on the basis of race, color, gender, national origin, age, religion, creed, disability, veteran's status, sexual orientation, gender identity or gender expression.

2. Decorations that may obstruct traffic and may potentially be a fire hazard (e.g. live Christmas trees) are not permitted in rooms, hallways, and suite corridors.
3. Hallway and suite decorations may be placed on resident room doors, bulletin boards, and in spaces approved by your RA and /or Area Coordinator. Lobby and lounge decorations must be approved through the Area Coordinator.
4. Decorations may not be placed within two feet of a fire protection system component (i.e. manual pull station, smoke detector, bell/horn/strobe/sprinkler, fire extinguisher, exit sign, emergency lighting, or any egress doorway).
5. Room and exterior room door decorations and wall hangings may only be hung with nondamaging materials or removable hangers and must not cover more than one third of the total door or wall space.

B. Electrical Appliances

1. Each individual residence hall room is restricted to a maximum of 1800 watts usage at any time. No single appliance can exceed 1000 watts or have an exposed heating element.
2. Two refrigerators are permitted in each room; however, it may not exceed 4.5 cubic feet in capacity with an electrical rating of 120 volts and no more than 2.0 amps when in operation.
3. Only one micro-refrigerator per person is permitted in each room.
4. Microwaves are permitted in the residence hall rooms
5. Halogen and octopus lamps are expressly forbidden in the residence halls.
6. Extension cords are not permitted in the residence halls.
7. Air fryers are only permitted in apartment-style housing (Alston Avenue, Eagle Landing and Martha St Apartments only). Air fryers must remain in the kitchen area. Air fryers can only be used and stored in the kitchen area of the apartment.
8. Convection and toaster ovens are prohibited in all residence halls.

C. Fire Safety

1. Starting a fire; activation a fire alarm without due cause; tampering with smoke/heat detectors; fire extinguishers, sprinkler heads; falsely reporting a fire emergency to police or fire department; and the unauthorized use or damage done to any emergency or safety equipment, are all prohibited.
2. The use of fire equipment for any reasons other than its intended purpose (e.g. sprinklers should not be used to hang clothes, covering smoke detectors) is prohibited.
3. Students will be held financially responsible for any damages and cleaning charges resulting from the unauthorized activation of the sprinkler system and subject to student conduct action.



4. In the event of a fire alarm or fire drill, all residents must evacuate the building completely and immediately. Residents must remain outside at the building's designated assembly point until instructed by fire department officials or University staff that they may re-enter.
5. Balconies, hallways, and stairwells must have clear passage at all times.
6. Storage of any item(s) that may pose a fire hazard in a residence hall room is prohibited. Items may include, but are not limited to any open flame source (i.e. celebratory candles or decorative candles), incense, hookah pipes, live cut trees (e.g. Christmas Trees) or flammable liquids.
7. The possession or use of combustible materials (e.g. hay, straw, Spanish Moss, cloth ceiling coverings) is prohibited.
8. Because of the fire hazard they represent, two prong extension cords, plug adapters, and halogen lamps and bulbs are prohibited. Residents using extension cords must use grounded three wire extension cords and/or surge protectors.
9. Space heaters are prohibited in residence hall rooms.
10. Splicing into or altering the electrical wiring in a residence hall is prohibited.

C. Housekeeping

1. Residents are responsible for the cleanliness of their rooms and/or suites.
2. Building residents and their guests are responsible for cleanliness of common areas.
3. Residents may not leave personal trash or pizza boxes in any public or shared areas (e.g. bathrooms and hallways).
4. Residents are responsible for removing their trash and/or recycling to designated outdoor trash containers on a regular basis as need to prevent health and safety concerns.
5. Residents are not permitted to store items in public or shared areas (e.g. hallways and **bathrooms**).

D. Keys/Locks

1. Unauthorized use, possession, or duplication of residence hall keys are strictly prohibited.
2. Switching and/or borrowing keys with another resident for any reason, including, unauthorized room changes, is prohibited. To conduct a proper re-assignment, residents should contact their Graduate Hall Coordinator or their Area Coordinator.
3. Failure to report lost keys is prohibited.
4. Residents are allowed one (1) grace key lockout without penalty. Students will be charged a lockout fee. Charges will be assessed and billed to the student's account at the end of each semester.

E. Room/Common Area Alterations

1. Students are responsible for returning their furniture to the designated positions at the end of the year as set forth by the community office.



2. Adhesive tape, staples, adhesive holders, brackets, tacks, and nails are not to be used on the walls, woodwork, floors, or ceilings.
3. Furniture is not to be removed for use in spaces other than its original location. Removal of residence hall room furniture from the room is prohibited.
4. Waterbeds are not permitted in the residence halls.
5. Residents are not allowed to paint any interior or exterior area of any residence hall space.
6. Additional locks may not be added to doors or other University property or equipment.
7. Damages that result from making room or common area alterations will be billed to the appropriate residents.
8. Damaged or missing furniture in public areas may be subject to group damage charges to all residents of the floor or buildings.

F. Safety

1. Breaking the plane of a window, breezeway or balcony is not allowed by a person or an object.
2. The throwing, dropping, propelling, pouring or handing of anything from windows, balconies, ledges, rooftops, and landings is strictly prohibited.
3. Climbing and repelling on any housing property is prohibited.
4. Following a building resident into a residence hall that is not of your own ("tailgating") is prohibited.
5. Propping open exterior doors creates a potential unauthorized entry,
6. Pranking that causes harm or the potential for harm is prohibited.
7. Precautionary steps should be take while cooking including turning on vents (where applicable), opening windows, and closely monitoring cooking food.
8. Window Damage including tampering with or removing any window screens, latches, stops, or apparatus in either resident rooms or public areas is prohibited.
9. Residents are expected to take responsibility for the overall general safety and wellbeing of themselves individually and the residential community as a collective. Engaging in any behavior that impedes the general safety and/or well-being of self and/or others is prohibited. This may include, but is not limited to; causing physical or psychological harm to oneself and/or others; creating an unsafe environment by leaving doors unsecured, particularly common use doors; failing to notify the appropriate authorities when knowledge exists of a situation that may impede the general safety and/or well-being of individuals and/or the community.
10. General safety also includes maintaining your living environment and your own person in accordance with reasonable health, cleanliness, and safety expectations.

Violation of a University policy, regulation or rule; the honor code; town ordinance; or state or federal law is prohibited.

Failure to comply with verbal, written, or published instruction by University staff, when such officials are working within the appropriate performance of their duties, is prohibited.

Abusive behavior that is threatening and directed toward University staff is prohibited.

Residents and approved guest(s) are required to present proper University identification or government issued identification to University staff in a cooperative manner when requested. It is a violation to knowingly supply University staff with false or misleading information that is needed for an official purpose, including the misrepresentation of identity or misuse of identification cards.

There are several other guidelines set forth by the Department of Residential Life that include but are not limited to content included in our housing agreements, website, and verbal or written instructions from staff members. These guidelines are considered part of the Community Living Standards.

Failure to adhere to Community Living Standards may result in termination of housing contract as well as referral to Office of Student Conduct and Community Standards or potential violations of the student code of conduct.
