

- (e) An individual may inform someone Smoking or using Tobacco on Campus Property of this policy and request that the individual comply with the policy. To report non-compliant individuals, please call (217) 333-8911 to inform the University of Illinois Police Department.
- (f) Individuals found to be noncompliant with this policy will be subject to a system of fines, sanctions, and an appeals process as set forth on the Smoke-Free Campus website.

§ 2-404 Chalking Policy

- (a) The use of water-soluble chalk, easily removed by rain, for expressive activity regarding any non-commercial topic is permissible on university sidewalks. Chalking is prohibited:
 - (1) On university property other than sidewalks including, but not limited to, all vertical surfaces, buildings, walls, planters, doors, trash receptacles, steps, fountains, benches, tables, signs, poles, columns, bus stops, light posts, and trees; and
 - (2) Underneath any covering where chalk would not be washed away by rainfall.
- (b) Chalking and other markings on university property that violate university policy or state or federal law are subject to removal by an authorized official of the university.
- (c) Individuals must not remove or tamper with chalking done by another person or organization.

§ 2-405 Protected Speech and Association

- (a) The right to speech and association protected by the First Amendment to the Constitution of the United States, such as peaceful protest and lawful demonstration, is recognized within the university community. The university retains the right to establish parameters to help provide a safe environment, protect property, and promote the proper functioning of the university's teaching, research, economic development and public service missions and business operations.
- (b) Specifically, expressive activities protected by the First Amendment are permitted in outdoor, publicly accessible areas of university property subject to the restrictions in the Expressive Activity on Campus Policy in the Campus Administrative Manual.

§ 2-406 Solicitation and Commercial Activity in University Residence Halls

Solicitation or commercial activity is prohibited in university residence halls except under the following conditions:

- (a) General Conditions for Canvassing
 - (1) All canvassers shall register before canvassing. A canvassing permit will be issued if the applicant has completed the registration form, has not had a permit revoked in the last nine months, and agrees to abide by the general conditions for canvassing. Canvassers must first register in the Office of the Dean of Students (301 Turner Student Services Building). Second, canvassers must register with the Office of Residential Life, Clark Hall 300. Information regarding whom to contact within each unit may be obtained at registration with the Office of Campus Regulations.
 - (2) Canvassers shall refrain from littering.
 - (3) Canvassers shall conform with visitation regulations.
 - (4) Canvassing may take place only between the hours of 2:00 p.m. and 10:00 p.m.
 - (5) Canvassing is prohibited in dining rooms and meal lines, i.e., lines formed after entering a dining room.
 - (6) Door-to-door canvassing is not permitted. Upon request to the housing unit, arrangements will be made to provide properly registered canvassers with space in high-traffic public areas of the residence hall.
 - (7) Violation of any of these six conditions is cause for revocation of permission to canvass.
- (b) Political Canvassing
 - (1) Political canvassing includes, but is not limited to:
 - (A) registering voters
 - (B) soliciting signatures on a petition for purposes of legally qualifying an individual as a candidate.
 - (C) campaigning for a political candidate for a municipal, township, school or other special district, county, statewide, or national election
