Trump on the Perry High School mass shooting one day after" This Facebook post was made on a message thread

regarding the Charlie Kirk Vigil, which was held in Linden, TN on 09/20/2025. This was a means of communication, via

picture, posted to a Perry County, TN Facebook page in which a reasonable person would conclude could lead to

serious bodily injury, or death of multiple people.
