Dear Mr. Kors,

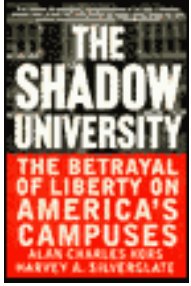

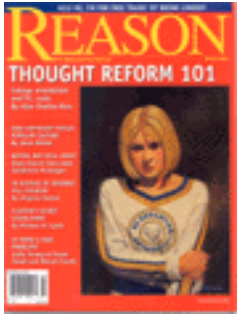

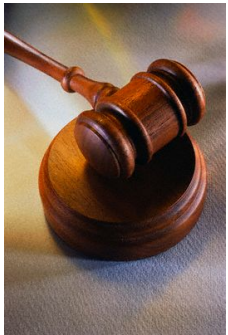
